# 2019 VOCA Funding

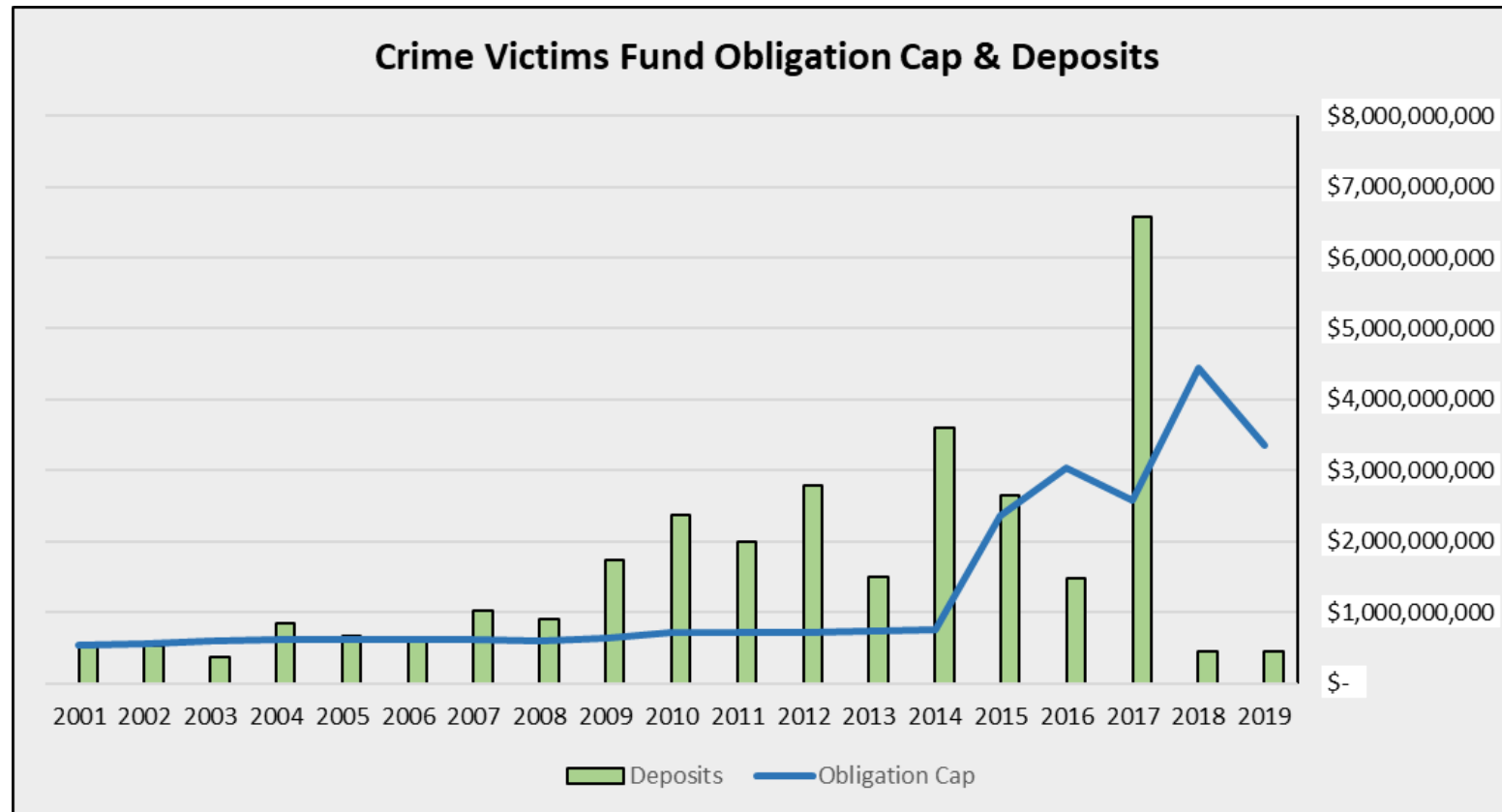
**FY 2018 VOCA Funding Cap: \$4.436 billion**

**FY 2019 VOCA Funding Cap: \$3.353 billion**

- VOCA Assistance Allocation \$2.253 billion (25% decrease from 2018)
- \$497.5 Violence Against Women for VAWA programs
- \$10 million Inspector General's Office
- 5 percent set aside (\$167.65 million) for grants to Indian tribes

As of June 30, 2019, the Crime Victims Fund balance is \$8.943 billion, but does not account for the 2019 Cap = \$5.59
