- FY 2018 Tribal Set-Aside-For the First Time!
 - On March 24, 2018: 3 percent of the Crime Victims
 Fund appropriation was set-aside for Indian tribes to
 improve services for victims of crime (up to \$133
 million).
 - Tribal set-aside funding was used to support grants to tribes, tribal consortia and tribal designees
 - Training and technical assistance designed to improve and expand victim services in Indian Country and build the capacity of tribes to respond to crime victims' needs.



FY 2018 OVC Tribal Set Aside (cont.)



- OVC developed a streamlined, two-phase application process to make it as easy as possible for tribes to apply.
- Phase 1 required applicants to submit a short program narrative, preliminary budget, required OJP docs.
- Phase 2 required offerees to submit the budget detail worksheet, a revised program narrative, and additional documents as indicated in the award offer, as well as clear conditions that restrict access to funds.
- 154 tribes or tribal organizations funded (1 did not accept so 153 funded)

- FY 2019 Tribal Set-Aside-For the Second Time!
 - 5 percent of the Crime Victims Fund appropriation was set-aside for Indian tribes to improve services for victims of crime (up to\$167,650,000).
 - Tribal set-aside funding was used to support grants to tribes, tribal consortia, and tribal designees
 - Comprehensive Tribal Assistance Program-CTAS
 - Standalone VSSA Solicitation
 - Training and technical assistance designed to improve and expand victim services in Indian Country and build the capacity of tribes to respond to crime victims' needs.
