Restitution in Victim Compensation Programs Learning Community

- The Restitution Resource Center convened and facilitated a national learning community of compensation administrators.
- A peer-led discussion included sharing promising practices, challenges, and approaches related to restitution recovery.



Key Themes

Managing restitution recovery involves staff time and resources.

- Communication with variety of system professionals
- Preparing documents for hearings and testifying in court
- Monitoring collections; setting up and following accounting procedures



Key Themes

- Number of people, how restitution duties are spread across staff, and competing priorities impact efforts.
- Programs use a variety of data management systems to manage claims. Some include modules for tracking restitution.
- Collections often lag well behind orders creating a situation where a positive return on investment may not be shown for some time.

Dedicating Resources to Effective Restitution Recovery

- Leverage existing systems for collections efforts.
 - Offset and collections programs run by state tax departments
- Active restitution collection requires significant staff time and data systems.
 - Locating people and communicating with them
 - Sending notices
 - Processing payments



Idaho Crime Victims Compensation Program

- The Crime Victim Compensation Program (CVCP) is considered a victim under the law.
 - Idaho Code 19-5304 (e)(3)
- Two dedicated Recovery Officers working on CVCP restitution.
- Building and cultivating relationships within criminal justice system.



Idaho Crime Victims Compensation Program

- Recovery Officer's record Restitution Orders
 - IC 19-5305
- CVCP's Recovery Rate is 30%
 - FY 2022 \$581,394 recovered \$1,995,509 paid
- Idaho's 2 largest Counties 60% order to request rate



Criminal Justice System Personnel

- Restitution involves many system personnel who need to be reached—and it is not identical in every state.
- Education and outreach are key building blocks.
 - Prosecutors
 - Judges
 - Clerks of court
 - Corrections
 - Supervision officers



Educating Personnel

Provide general information on compensation program who it serves, how it works, why compensation program restitution is important.

- Annual conferences for system professionals
- Direct outreach in counties or districts with high number of claims
- Providing compensation program data for specific jurisdictions



Educating Personnel

- Create example packets of claim documents the program submits for restitution orders to familiarize people with program's information.
- Provide program manuals or summary documents.
- Identify partners in judiciary and other professions to "champion" restitution efforts and advance reforms.



Court Case Data

Access to case data is key.

- Is court data centralized or decentralized?
- What access do you have, or can you get?
- Integrations are ideal, but case look-up works when needed.



Identifying Barriers

- Lack of prioritization of restitution across the system directly impacts compensation programs.
- Lack of authority to monitor cases and directly collect payments hampers restitution recovery.
- Hierarchy of disbursement for other court-ordered financial obligations may complicate direct collections.



Overcoming Challenges

- Proposing or supporting legislation that enhances collection processes, prioritizes payments, and provides consistent enforcement
- Advocating for consistent compliance with statutes and rules
- Institutionalizing compensation program procedures
 - For example, sending payment notification to prosecutor each time payment is made



Overcoming Challenges—Developing Partnerships

- Formal and informal partnerships can be effective.
 - Formalized partnerships endure staffing changes.
- Partnerships that integrate data systems can help improve restitution monitoring.
 - Data-sharing agreements
