

2023 NCVRW Community Awareness Project Project Summaries

Alabama

Applicant: 1175 – Mobile County District Attorney's Office

Amount Approved: \$4,980.24Project Description: MCDA 2023

The primary focus of this project is a mass print campaign, including two high-traffic locations throughout the service area and postcards mailed to victims and/or their families. The postcards will also be mailed to law enforcement and service agencies throughout the community. The logo and artwork will be featured on all printed materials, the MCDA website, and social media platforms along with a link to the NCVRW website.

CAP funds will be used for giveaways (including candle tins and tissues), radio and social media ads, billboards, postcards, photographer, videographer, and butterflies for release.

Applicant: 1236 - Crime Stoppers of Metro Alabama

Amount Approved: \$4,304.00

Project Description: One Heart in the Park

The event will be the Third Annual "One Heart in the Park," which will be held on Saturday, April 29, 2023, at the City Walk in downtown Birmingham. Over 40 agency participants will set up booths or tents to present the services and advocacy they offer to crime victims. Each agency will have representatives, handouts/information, and promotional giveaway items. Survivors will have the opportunity to spend time privately with a representative if immediate assistance or information is needed.

CAP funds will be used to pay for rental space, audio equipment rental, tent, tables, chairs, supplies, signs, and printing for the event.

Applicant: 1294 – Montgomery County District Attorney's Office

Amount Approved: \$5,000

Project Description: 2023 "An Evening of Remembrance"

On Tuesday, April 25, 2023, the Montgomery County District Attorney's Office will host "An Evening of Remembrance" in observance of NCVRW. This impactful program will be punctuated by an "In Memoriam" multimedia presentation featuring images of Montgomery County homicide victims (gun violence, domestic violence, DUI, and other felony crimes) and expressions of love from their families. Another poignant part of the evening will be the powerful messages from the featured speakers about coping in the aftermath of a violent crime and pressing forward on a path to healing. In addition, representatives from area victims' rights and support advocacy groups will be on hand to share information and answer questions at resource tables set up in the entryway of the venue.

CAP funds will be used for digital billboards advertising event, printing of Victims Resource Guides, honorarium for audio/visual tech, social media advertising, and giveaways (buttons, keychains, etc.)

Alaska

Applicant: 1244 – Aleutian Pribilof Islands Association, Inc.

Amount Approved: \$5,000

Project Description: NCVRW Bond with Kindness 5k and Candlelight Vigil

CAP funds will be used to purchase supplies for the "NCVRW Bond with Kindness 5k and Candlelight Vigil" in honor of victims of crime. These include t-shirts, posters, postage, flameless candles, medals, banners, sound system, canopy, and giveaways (i.e., mugs, essential oils, gaiters).

Applicant: Alaska – 1279 – Victims for Justice

Amount Approved: \$5,000

Project Description:

Victims for Justice (VFJ) will observe NCVRW with targeted outreach strategies that highlight victims' rights in the judicial system and three main activities: a tree ceremony, victim service awards, and a digital campaign.

CAP funds will be used for speaker recognition, sound equipment rental, supplies (i.e., pens, hand sanitizer and tissues), social media and billboard campaigns.

Arizona

Applicant: 1231 – Pima County Behavioral Health

Amount Approved: \$5,000

Project: 2023 NCVRW in Pima County

CAP funds will be used to execute a mass social media advertising campaign to enhance the public's awareness of NCVRW and the rights and services for victims of all types of crime. These will include direct buys of various types of social media.

Applicant: 1242 – Pinal County Attorney's Office

Amount Approved: \$5,000

Project: NCVRW Events

Pinal County Attorney's Office will utilize CAP funds to help pay for advertising events that will be held for NCVRW. These include resource fair events in Casa Grande, Pina Central, and Maricopa. A purchase of social media, geo targeted ads, and newspaper ads will enhance attendance to this event. Giveaways will be purchased as well. Those include arm lights and safety/reflector whistles.

Arkansas

Applicant: 1302 – NWA Center for Sexual Assault

Amount Approved: \$3,816.70

Project: Voices Gala

Each year, NWA Center hosts an annual Voices Gala to bring together survivors and the local community, share the impact in Northwest Arkansas, and educate the public about work and resources. This event also features a resource fair and includes participation from several other nonprofit organizations.

CAP funds will be used to promote the next event in April. This will include educational materials, mailers, social media ads, event banners, and other promotional brochures and flyers to raise awareness of NCVRW, the Voices Gala, and participating community partners. Funds will also be used for standing banners (translated in Spanish and Marshallese to better serve these populations), award plaques and bouquets for honorees and speakers, and resource packets with information on where to seek assistance for different types of crime. All items will be designed to align with NCVRW's theme and colors and will feature its logo.

Applicant: 1326 – Crime Victims Assistance Association of Arkansas (CVAAA)

Amount Approved: \$5,000

Project: Arkansas Crime Victim Rights Week

CVAAA will coordinate public awareness events in the Central Arkansas area during NCVRW, April 23–29, 2023. This will be done by holding public awareness events, purchasing and distributing promotional items, printing resource cards for distribution, printing t-shirts that include the 2023 theme, printing information about crime victims' rights, and printing a poster that can be placed in public buildings that highlights the theme of the event of 2023 as well as victims' rights.

CAP funds will be used for event rental space, printing costs for programs, poster, etc., translation services, candles, t-shirts, banner billboards, and promotional giveaways (flashlights, ribbons, etc).

Applicant: Arkansas – 1333 – Committee Against Spouse Abuse

Approved Amount: \$5,000

Project: Committee Against Spouse Abuse - (CASA Women's Shelter)

CASA Women's Shelter (Committee Against Spouse Abuse) will partner with the following groups to raise awareness of victims' rights: Arkansas Coalition Against Domestic Violence, Arkansas Coalition Against Sexual Assault, Jefferson County Victims' Rights Advocacy Unit, the City of Pine Bluff, City of White Hall, Jefferson County, University of Arkansas at Pine Bluff, Southeast Arkansas Community College, as well as many other businesses and organizations. Both campuses in Jefferson County will be provided with literature containing information on victims' rights, services, and resources. Events will include a town hall meeting, candlelight vigil, and survivor art exhibit.

CAP funds will be used to purchase printed brochures, flyers, banners, T-shirts, and tote bags for the event.

California

Applicant: 1179 – Riverside County DA's Office, Division of Victim Service

Amount Approved: \$5,000Project: NCVRW Events

This project will promote and enhance the public's awareness of rights and services for victims of all crime types while offering victims, survivors, and their families activities that will elevate and engage survivor voices to effect change. Based on past attendance and support of previous candlelight vigils, it is estimated that close to 2,000 people will attend the in-person events countywide.

CAP funds will be used to purchase giveaways (stress balls, stylus pens, tote bags, journals, candles, canvases, ribbons, etc.). These giveaways will be available for attendees at these events.

Applicant: 1347 – Sonoma County District Attorney's Office (CA)

Amount Approved: \$5,000

Project: Community Event

Project funds will be used to host a community event to honor victims of crime and to highlight providers' efforts to improve services for all in the community. The focus will be on informing attendees about services available to victims of crime, honoring the lives of those lost due to violence, and honoring the service providers in the community.

CAP funds will be used to advertise on buses, newsletters, newspaper advertising, posters, social media marketing, promotional items (tote bags, pencils, whistles, stuffed animals, etc), portable restroom and handwashing station rental, and reserved parking spaces for police, fire department and food trucks.

Colorado

Applicant: 1314 – Invention, Inc.

Amount Approved: \$4,137.50

Project: Celebrating Crime Victim Rights Week: Survivor Voices and PTSD

A community event to raise awareness of victims of crime who have PTSD because of their victimization will be held. This one-time event will be held in collaboration with a local district attorney's office in Golden, Colorado, and the public and media will be invited.

CAP funds will support speaker fees, brochures, posters, 2022 Colorado Victim Rights Act information cards, fact sheets on PTSD, location rental, and grant-approved promotional giveaway items.

Connecticut

Applicant: 1225 – Human Resources Agency of New Britain, Inc.

Amount Approved: \$5,000

Project: We Reflect and Remember: New Britain Marks National Crime Victims' Rights Week

HRA will manage and host New Britain, Connecticut's communitywide events during NCVRW in late April 2023. All community events will be open to the public and engage all victims/survivors of crime interested in taking part. All events will be free with no entrance or participation fees. There will be no form of fundraising associated with these events.

CAP funds will be used for event supplies including printed flyers, t-shirts, banners, bags, and balloons screened with the NCVRW logo and tagline as well as butterflies for the kickoff ceremony and artificial candles for the vigil.

Applicant: 1340 – The Underground NE

Amount Approved: \$5,000

Project:

CAP funds will be used to print and share flyers, buttons for volunteers, and coasters to raise awareness about resources available to crime victims. Flyers will be posted in public restrooms, waiting rooms, recreational centers, and community boards in community establishments where people congregate, and coasters will be placed in many of the establishments previously listed, as well as bars, pool halls, recreation centers, etc. throughout Connecticut.

Project: Delaware Recognizing Crime Victims' Rights Week

For this year, a public event highlighting the Delaware Victims' Bill of Rights and how to work with it on a professional and personal level will be hosted by Delaware Victims' Rights Task Force.

CAP funds will be used for a speaker, location and A/V equipment rental, giveaways (tote bags, bookmarks, journals, etc.), printing of invites, and social media advertising.

District of Columbia (DC)

Applicant: 1260 – Network for Victim Recovery of DC (NVRDC)

Amount Approved: \$4,995.65

Project: 2023 NCVRW-CAP

NVRDC proposes hosting the District's observance of 2023 NCVRW with the following key events that seek to enhance the public's awareness of rights and services for victims of all types of crimes in DC. During the week of April 23–29, NVRDC will host an NCVRW Walk & Community Block Party to commemorate the victims of violence in the District in the last year and highlight the growing number of resources for victims of crime.

CAP funds will be used for event equipment rental (chairs, tables, etc.), printing, translation services, and social media advertising.

Project HELP (PHI) and community partners will host an NCVRW 2023 awareness campaign throughout SWFL social media (i.e., Facebook, Instagram, Twitter, and LinkedIn) and via the *Naples Daily News* and Wink News media outlets. This will be followed by a Family Fun and Safety afternoon at the park on April 27, 2023, in collaboration with the Naples Police Department, Collier County Sheriff's Office, and Collier County State Attorney's Office.

CAP funds will be used for boosting social media promotional campaigns; rental costs for park, tables, chairs, podium, speakers, and microphone; photographer; videographer, video editing, and full rights to video content; photobooth with NCVRW logo/colors/theme printed on photos; the purchase of materials for face painting; butterflies for the butterfly release; table runners and banner with NCVRW logo/colors/theme; and design and printing of crime victim resources and services informational handouts for the event (i.e., victims' rights, sexual assault and grief brochures, project help rack cards with NCVRW logo and theme, crime victim programs, services and support group flyers, and event program all in English, Spanish, and Creole). Funds will also enable the distribution of NCVRW logo/colors/theme giveaways at the event (i.e., tote bags, car magnets with PHI logo and #StopTheViolence, silicone wristbands, hand sanitizer, pens, fans, whistles, and recognition awards for stand-out community partners).

CAP funds will be used to purchase script package, rights for the production, speaker's fees, travel and lodging, and the printing of programs, and giveaways (coffee sleeves, tote bags, pins).

Idaho

Amount Approved: \$4,938

Project: 2C Country Supports Crime Victims

There will be small events/video presentations throughout the week of April 23–29 with a grand finale event (April 28) geared specifically to Idaho—a true "boots on the ground" event featuring country music, dancing, and a country line dance lesson taught by the owner of Country Rose Dancing (CRD) from Caldwell, Idaho.

CAP funds will be used to purchase t-shirts, advertising, candles, scrolls and feather pens.

Illinois

Applicant: 1246 – Legal Aid Society of Metropolitan Family Services

Amount Approved: \$4.898

Project: 2023 LAS Justice Corp CAP

The Justice Corps will implement educational workshops and a community event for the week of April 23–29, 2023. The community education events will be located at partner CBOs from CP4P that serve the 28 Chicago Community Areas (CCA) with the highest rates of community violence. The Light in the Night event will be on Friday, April 28, 2023.

CAP funds will be used for giveaways including ear pod cases, spray cleaner and cloth, sunset stainless-steel tumblers, tote bags, and calendars.

NCVRW will be celebrated through a multicounty campaign. Digital billboards, social media campaigns, information tables, and a Celebration of Survivors will target all crime victims. In addition, the distribution of information cards, table tents, and giveaways focusing on various types of victimization will help ensure the campaign is far-reaching and inclusive.

CAP funds will be used to purchase digital billboards, foam board signs, peace poles, candles, lip balm, notebooks, flashlight/lanyard, social media boosts, and printing of informational rack cards.

Iowa

Project: Polk County Attorney's Office

Polk County Attorney's Office, Crisis & Advocacy, Wellness Department, and Iowa's 5th Judicial District Department of Correctional Services have formed a Crime Victim Rights Committee. Through this collaboration, a 2nd Annual Victims' Rights Week 5k & Kids Fun Run/Walk event is being planned to honor crime victims.

CAP funds will be used to purchase bus advertising, event space, portable bathrooms for run/walk, medical supplies for the event, and t-shirts.

Applicant: 1210 – Catholic Charities Domestic Violence & Sexual Assault Program

Amount Approved: \$5,000

Project: Annual NCVRW Luncheon

Catholic Charities Domestic Violence and Sexual Assault Program will partner with The Fourth District Department of Correctional Services to plan and host the Annual NCVRW Luncheon the week of April 24–30 during NCVRW.

CAP funds will be used for printing of informational victim cards, brochures, posters, survivor speaker fee, outdoor banner, retractable banner, and giveaways (stadium cups, grocery tote, stress balls, and lanyards).

Applicant: 1265 - Domestic/Sexual Assault Outreach Center (DSAOC)

Amount Approved: \$4,997.87

Project:

DSAOC will collaborate with grocery stores to offer free grocery totes for customers. Each of the grocery stores are in small rural areas as well as larger towns. These are large chain stores, some of which are the only grocery store in town; populations range from 2,258 to 66,971 residents.

CAP funds will be used to purchase grocery bags, brochures, lip balm, and web cam covers.

Kansas

Applicant: 1301 - Kansas Department of Corrections, Office of Victim Services

Amount Approved: \$4,639

Project: Kansas Cold Case Card Awareness Campaign

The Kansas Department of Corrections (KDOC) and the Kansas Bureau of Investigation, in partnership with the Kansas Association of Chiefs of Police, the Kansas Sheriff's Association, and the Kansas Peace Officers Association, developed Cold Case Cards as a way of generating tips that may help resolve unsolved crimes. Each card in the deck includes brief information about an unsolved crime along with a phone number for anyone with information to call: 1-800-KS-CRIME. These cards highlight case details in the hope that anyone familiar with a case will come forward with information leading to its resolution. The program was first piloted in Florida in 2007 and has since been successfully replicated in other states.

CAP funds will be used for printing stickers and decks of cards for NCVRW.

Kentucky

Applicant: 1178 – Kentucky Office of the Attorney General, Office of Victim Advocacy

Amount Approved: \$2,763.86

Project: Survivors Council Awareness Day

OVA is proposing to host a third annual NCVRW event at Kentucky's state capitol building on April 26, 2023.

CAP funds will be used to purchase acrylic wedge award, outdoor plaque, packets of seeds, candles, printed cards, rocks for painting, art supplies, ribbons, poster, survivor speaker and travel expenses.

Louisiana

Applicant: 1364 – Louisiana Foundation Against Sexual Assault (LaFASA)

Amount Approved: \$4,817

Project: Helping Victims in CENLA

LaFASA's efforts will primarily consist of a multimedia campaign with a single event that will support its ongoing coalition efforts by building a cohesive message to lift victims of crime and bring awareness to programs that provide assistance.

CAP funds will be used to purchase radio advertising, billboards, amphitheater rental, chair rentals, and giveaways (tote bags, first aid kits, and bandanas).

Maine

Applicant: 1198 – Hope and Justice Project

Amount Approved: \$4,996.21

Project: 2nd Annual Color ME 5k Run/Walk for Hop

Hope and Justice Project will promote the 2nd annual Color ME 5k Run/Walk for Hope on Saturday, April 29, 2023.

CAP funds will be used to purchase supplies for the color run, t-shirts, yard signs, banner, advertising, and event space rental.

Maryland

Applicant: 1190 - Maryland Crime Victims' Resource Center

Amount Approved: \$5,000

Project: Make a Difference for Victims' Rights 2nd Annual 5K and Resource Fair

Maryland Crime Victims' Resource Center, Inc. (MCVRC) will host the 2nd Annual 5k Walk and Resource Fair. This event will honor, remember, and pay respects to survivors and victims of all crimes.

CAP funds will be used to purchase t-shirts, social media advertising, sound system rental, and event space.

Applicant: 1282 – Board of Carroll County Commissioners

Amount Approved: \$5,000

Project: Carroll County MD State's Attorney Victim Memorial

On Sunday, April 23, 2023, a memorial will be held to honor and support victims of crime and their families. There will be an opportunity to write their name on a dove/heart that will be attached to a banner and raised for display during the memorial service.

CAP funds will be used to purchase event space rental, video production, music performer, and to broadcast/livestream of memorial service.

Michigan

Applicant: 1239 - Prosecuting Attorneys Association of Michigan

Amount Approved: \$5,000

Project: Crime Victims' Rights Vigil

This organization will be the primary host for the state's Crime Victims' Rights Vigil, which will be hosted in person at the state capitol building. The association consists of all 83 county prosecutors, the state attorney general, and U.S. attorneys in Michigan.

CAP funds from this grant will be used to purchase electronic billboards, outdoor signage, color banners, and pens for giveaway.

Applicant: 1350 – Detroit Public Safety Foundation

Project: NCVRW Walk and Fair

Funds will be used to support a series of events offered in partnership with DPD throughout NCVRW that will raise public awareness about victims' rights and honor all victims.

CAP funds will be used to print literature about victims' rights, t-shirts with information on the back about how to access services, billboard advertising, printed plastic bag, event rental equipment, stadium cups, promotional materials, pens/pencils, printed resource information, and a banner.

CAP funds will be used to purchase billboards, a social media campaign, and promotional items (clips, water bottles, tote bags, t-shirts).

Project: Red Lake Band of Chippewa Indians Victims' Services Art Show

Multiple events will be held throughout the entire week. Those include multiple location resource fairs and awareness walk.

CAP funds will be used to purchase supplies for the various events, giveaways (rubber bracelets, tote bags, t-shirts, banner, water bottles, and culturally specific items.

Mississippi

Applicant: 1291 – The Shafer Center for Crisis Intervention

Amount Approved: \$5,000

Project: NCVRW Office Challenge

The project plan is to coordinate an "office challenge" throughout the 11-county service area. In the weeks leading up to 2023 NCVRW, the committee members will challenge different businesses and offices to encourage their employees to wear their 2023 t-shirts (which will be distributed beforehand) on a designated day (TBD) during NCVRW.

CAP funds will be used to purchase banners, picture printing supplies, signs, framed awards.

Project: Escuchame (Listen to Me)

El Pueblo has developed a "Did You Know?" campaign to raise public awareness of crimes, the intersection of immigration status and victims' rights, and victims' resources (especially legal and mental health resources) in Central and Coastal Mississippi. This campaign is linguistically and culturally appropriate for the targeted underserved populations of immigrants and people with limited English proficiency (LEP).

CAP grant funds will be used for printing informational brochures and giveaways (fidget toys, keychains, pens, USB drives, and pop sockets.
